## **New MasterCard EMV Chip Debit Cards**

All SFCU Debit Cards now come with built-in EMV chip technology. This gives you greater fraud protection when you use your card at a chip-activated terminal. The card is not only more secure — it's also easy to use.

We are pleased to announce SFCU will be issuing EMV Chip Debit Cards to all our current MasterCard Debit Card Holders. This process has begun and the process will be completed by early November. You will then have ten days to update your information with any business/merchant you have given your card number to for recurring payments before your old card is deactivated. ### Same Day ACH Payments

Over the past several months and continuing until March 2018, the National Automated Clearing House Association (NACHA) is phasing in Same Day ACH. This has a direct impact on many of our members. The initial phase of Same Day ACH made it possible for deposits that are sent through electronically to member accounts to be deposited the same day they were originated. The second phase of Same Day ACH takes effect on September 15, 2017 and will affect debits or payments that come out of your account to occur on the same day they were initiated. How will this affect you? If you pay for something online (whether a purchase or a bill) and use your checking account to pay, it could come through the same day that you authorized it. If you write a check at a retailer and they scan the check and give it back to you, that check amount could clear your account that same day. This also means that withdrawals may post to your account before deposits. If you do not have it already, Sunrise Family Credit Union's Online Banking "Home Branch" is a great way to stay abreast of the activity on your account 24/7.
